Assurance #5

The District/PSA, in consultation with a local health department will develop guidelines concerning appropriate methods for delivering pupil instruction for the 2020-2021 school year that is based on local data that are based on key metrics. *Note: A determination concerning the method for delivering pupil instruction shall remain at the District/PSA Board's discretion.* Key metrics that the District/PSA will consider shall include at least all of the following:

- [COVID-19 Cases or Positive COVID-19 tests](#)
- Hospitalizations due to COVID-19
- Number of deaths resulting from COVID-19 over a 14-day period
- COVID-19 cases for each day for each 1 million individuals
- The percentage of positive COVID-19 tests over a 4-week period
- Health capacity strength
- Testing, tracing, and containment infrastructure with regard to COVID-19

### Reconfirm instructional delivery method:

Based upon all assurances provided within the Extended COVID-19 Learning Plan, in particular, Assurance #5 stated above, Hudsonville Public Schools will continue to provide two options to HPS families: 100% in-person instruction (every day, all day) and 100% online instruction (i.e., Eagle Virtual). Eagle Virtual will continue to be offered to families as a choice during the current status of the worldwide pandemic due to COVID-19. In-person instruction will occur in each of our Hudsonville school buildings during phases 4 -6 of the Return to Learn plan. HPS students and staff will follow strict protocols as advised by the MI Safe Schools Roadmap. HPS has developed the following guidance documents for staff, students, and families regarding safety protocols and instructional delivery;

School/District Closure Plans - We have updated our HPS Return to School Roadmap Teaching and Learning Handbook to include [updated expectations](#) for teaching and learning during a potential school or district closure. Plans were refined during the month of October based on lessons learned from Eagle Virtual as well as adding many additional technology resources to the plan for teachers to access in the first days of closure. The plan includes details for closure lasting up to 2 weeks and for closure lasting more than two weeks. Device distribution and built-in time for professional learning and collaboration among grade-level and department teams will be prioritized at the onset of an extended closure (more than 30 days). Additionally, student-parent communication and orientation to instructional expectations are slated in the first days of an extended school/district closure.

### Reconfirm how instruction will be delivered for each grade level:

#### Elementary (Grades PK-5):

Hudsonville Public Schools will continue to provide in-person instruction (every day, all day) and online instruction (i.e., Eagle Virtual). Eagle Virtual will continue to be offered to families as a choice due to the current status of the COVID-19 worldwide pandemic. In-person instruction will occur in each of our Hudsonville school buildings. HPS students and staff will follow strict protocols as advised by the MI Safe Schools Roadmap and MDHHS guidance.

#### Middle School (Grades 6-8):

Hudsonville Public Schools will continue to provide in-person instruction (every day, all day) and online instruction (i.e., Eagle Virtual). Eagle Virtual will continue to be offered to families as a choice due to the current status of the COVID-19 worldwide pandemic. In-person instruction will occur in each of our Hudsonville school buildings. HPS students and staff will follow strict protocols as advised by the MI Safe Schools Roadmap and MDHHS guidance.

#### High School (Grades 9-12):

Hudsonville Public Schools will continue to provide in-person instruction (every day, all day) and online instruction (i.e., Eagle Virtual). Eagle Virtual will continue to be offered to families as a choice due to the current status of the COVID-19 worldwide

pandemic. In-person instruction will occur in each of our Hudsonville school buildings. HPS students and staff will follow strict protocols as advised by the MI Safe Schools Roadmap and MDHHS guidance.

**Reconfirm whether or not the district is offering higher levels of in-person instruction for English language learners, special education students, or other special populations:**

Benchmark assessments (K-8) and formative assessments (9-12) assist in the process of identifying students in need of additional support. Identified students continue to have access to interventions and/or support. Schedules vary by grade band. English language learners are receiving in-person instruction based on the Hudsonville Public School Language Assistance Program. Students with disabilities continue to have access to applicable programs and services according to their individual plans.
