Student Council Report

Jane Tacoma, Senior, reported that five seniors received a \$500 scholarship for their service to the Student Council for the past four years. Building Reports

Bauer Principal Josh Meersma reported that staff recognized students who are consistently following building expectations and demonstrated high levels of character with a SOAR breakfast celebration. He shared that teachers administered mid-year benchmark assessments and are having data dialogue discussions to determine next steps of how to support students. He shared details about a Valentine's Day project for staff that creates a living culture of positive feedback for collogues.
