INTRODUCTION AND METHODOLOGY

As Hudsonville Public Schools revisits and updates its SOAR strategic plans for SOAR V, it recognizes it is essential to communicate with and involve its communities of parents, residents, staff and students into its planning process. Consequently, Hudsonville Public Schools has asked Gartner & Associates to conduct this related community research.

The value of this community research is threefold:

1. First, this community research collects each stakeholder group's distinct perceptions of the Hudsonville district's relevant education needs, issues, culture and performance.

2. Simultaneously, this research enables Hudsonville Public Schools to dialogue with its various community members and strengthen its relationship with them.

3. Finally, this research also acts to inform district residents, staff and students about the issues facing Hudsonville Public Schools and alternative solutions.

This community research centers around plans to improve teaching and learning within Hudsonville Public Schools -- including academic achievement, instruction and curriculum, supporting transitions from one school levels to the next (such as elementary to middle school), parents support for their children's learning, the surrounding educational culture and environment, and supporting programs, services and infrastructure comprising the total educational experience for Hudsonville students and their families.

The initial phase of this community research was a set of seven focus group discussions in February-March 2023 with parents, grandparents, other residents, business people, staff and students to confirm major issues and guide development of survey questionnaires.

This phase is an online survey of **1,350** parents with children currently attending Hudsonville Public Schools, with their responses occurring March 29 – April 21, 2023. We received a total 1,402 responses, of which 52 are other residents who either have never had children attend or had children previously but not currently attend Hudsonville Public Schools.

Online surveys were also conducted this Spring 2023 with Hudsonville Public Schools staff and Hudsonville high school 9th-12th graders.

Hudsonville Public Schools emailed a survey invitation, as well as a reminder email, to all 6,011 parents from the district's superintendent and Board president. This email explained the purpose of the survey and requested parents to click on the survey link within the email, taking them directly to the survey hosted rather transparently by Survey Monkey. In order to assure complete anonymity and confidentiality, we did not require any login with a user id and password.

The sampling error associated with a completed sample of 1,350 current parents (proportionately adjusted to the population of 6,011 parents invited) ranges from 0.5% to 2.4% at the 95% confidence level.

In addition to the total current parents percentage findings, cross-tabs percentages are provided by school level. The number of responses by school level are:

Responses and frequency distributions by school building are also available in the companion Excel response database. Data from the 2020 Parents SOAR 4 survey is also included in this report.

Gartner designed and directed the research, developed the questionnaire in consultation with Hudsonville Public Schools, provided web access, analyzed the data, and provided this written report of the survey findings.

The contributions of Dr. Doug VanderJagt and his leadership team are duly and appreciably noted here.

SUMMARY OF FINDINGS

1. 75% of current HPS parents are **overall "completely or very satisfied" with HPS**.

Another 9% are "somewhat satisfied," while 1% are "slightly satisfied" and fewer than 1% are "not at all satisfied."

HPS Early Childhood Center parents (97%) have the highest overall "completely or very satisfied" percentage, while HPS high school parents have the lowest (66%).

2. More frequently mentioned **unaided reasons "why not completely or very satisfied"** include:

- Concerns about enrollment growth, especially at the high school, with too many kids at each grade level and in each classroom.
- Some parents feel not enough attention or resources are given to their children who are academically advanced and not challenged enough in school.
- Other parents feel not enough attention or resources are given to their children who are struggling in school academically or behaviorally.
- ✤ Misbehaving students are not held accountable.
- As expected, some parents feel HPS and public schools have a too progressive political agenda, while other parents feel that the district is increasingly following an agenda that is exclusionary and discriminatory.

3. 77% of current HPS parents would **recommend to families to enroll their children in HPS**, including 39% who say "definitely yes."

"Definitely yes" replies include 56% of current HPS Early Childhood Center parents, 41% of the elementary school parents, 36% of the middle school parents, and 33% of the high school parents.

10% would not recommend to families to enroll their children in HPS, while 13% reply "nor sure."

4. More frequently mentioned **unaided reasons to recommend Hudsonville Public Schools** include:

- Dedicated, caring and outstanding teachers and staff.
- * High academic expectations, standards and performance.
- ♦ Wide variety of classes, electives, and extracurricular activities.

5. 81% of current HPS parents award an A or B as their **overall grade of Hudsonville Public Schools**, including 41% who give an A grade.

15% give a C grade to HPS overall, while 4% assign any grade lower than C.

6. Among current parents at each Hudsonville school, the highest percentage of an A grade to their individual school is awarded by South Elementary parents (82%).

An "A" grade at the other seven elementary schools from their individual school parents include: Park (75%), Forest Grove (73%), Jamestown Lower (72%), Bauer (66%), Georgetown (65%), Alward (64%), and Jamestown Upper (58%).

67% of the Early Childhood Center parents award an "A" grade to their school.

More Riley parents (55%) than Baldwin (37%) parents give an "A" grade to their schools.

36% of the high school parents assign an "A" grade to Hudsonville High School.

7. **Among 23 suggested improvements**, the highest "extremely or very important" (top-two response options) percentages from current HPS parents is definitely: "

◆ "More instruction and classes relevant to careers and the workplace" (83%)

At least 75% of current HPS parents also consider the following as "extremely or very important" improvements:

- ✤ "More support to improve reading skills" (79%)
- "Emotionally safer schools" (76%)
- "Physically safer schools" (75%)
- ♦ "More attention to address and discourage cyber (texting/online) bullying" (75%)

The three least rated as important improvements, with less than 50% of all current HPS parents replying "extremely or very important" are:

- ✤ "More online or blended learning opportunities" (37%)
- ✤ "Stricter classroom discipline" (45%)
- "Fewer students in a classroom even if it means eliminating other things to afford the additional teaching staff" (47%)

8. More frequently cited **unaided reasons why some current HPS parents do not send all their children to HPS** include:

- Personal family reasons, such as divorce and custody arrangements or a parent works for another school district
- Prefer a Christian school education
- Preschool program
- Prefer a smaller school environment
- Special education needs
- Former student harassed or bullied too much at HPS
- ♦ Do not agree with public school's culture; political perceptions.

9. Many current HPS parents feel **"extremely or very welcome" when visiting their child's school**, ranging from 91% for current elementary school parents to 66% for high school parents.

10. Most current Early Childhood parents (94%) and many elementary school parents (87%) agree that the **HPS school environment is welcoming to ALL students and families**. However, the combined "definitely or probably yes" replies then decline to 75% of middle school parents and 71% of the high school parents.

11. Most current Early Childhood parents (94%) and many elementary school parents (86%) agree that the **HPS school environment supports ALL students to feel that they belong at their school**.

However, the combined "definitely or probably yes" replies then decline to 70% of middle school parents and 57% of the high school parents.

12. Most current Early Childhood parents (92%) and many elementary school parents (84%) agree that the **HPS school environment supports ALL students to feel that they are connected to other students at their school**.

However, the combined "definitely or probably yes" replies then decline to 70% of middle school parents and 62% of the high school parents.

13. Almost all current Early Childhood parents (97%) and many elementary school parents (87%) agree that the **HPS school environment provides opportunity for ALL students to grow and succeed**.

However, the combined "definitely or probably yes" replies then decline to 77% of middle school parents and 74% of the high school parents.

14. 62% of current HPS parents feel **"extremely or very informed" about the Hudsonville district overall**, including 20% who feel "extremely informed." Just 1% reply "not at all informed."

15. Noticeably more current HPS elementary school parents (81%) feel **"extremely or very informed" about their child's particular school** than do Early Childhood Center parents (68%), middle school parents (70%), and high school parents (68%).

16. School Messenger (80% "extremely or very helpful") and school newsletters (72%) are considered as the most helpful communications resources by current HPS parents to keep them informed about the district.

PowerSchool (58%) and the district newsletter Appleseed (52%) are the next most helpful. Comparatively, the staff blogs (49%), district website (41%), and school websites (37%) receive "extremely or very helpful" mentions from less than half of all current HPS parents.

17. Slightly less than three-fourths of current HPS parents are "completely or very satisfied" (72%) with **how HPS communicates to keep them informed about** *recent* **events and news in their child's CLASSROOM**.

Similarly, 70% of current HPS parents are "completely or very satisfied" with **how HPS** communicates to keep them informed about *upcoming* events and news in their child's CLASSROOM.

18. 70% of current HPS parents are "completely or very satisfied" with **how HPS** communicates to keep them informed about RECENT events and news in their child's SCHOOL.

Similarly, 71% of current HPS parents are "completely or very satisfied" with **how HPS** communicates to keep them informed about UPCOMING events and news in their child's SCHOOL.

19. 56% of current HPS parents are "completely or very satisfied" with **how HPS communicates to keep them informed about RECENT events and news throughout the DISTRICT**.

Similarly, 55% of current HPS parents are "completely or very satisfied" (67%) with **how HPS** communicates to keep them informed about UPCOMING events and news throughout the DISTRICT.

20. 37% of current HPS parents are "completely or very satisfied" with **how HPS** communicates to keep them informed about legislative action that impacts public education.

21. As expected, many more current parents at HPS elementary schools (79%) and Early Childhood Center (66%) **feel "extremely or very involved" in their children's schools** than do current parents at the middle schools (44%) and high school (36%).

22. 47% of current HPS parents say Hudsonville community residents are **"extremely or very involved" with Hudsonville Public Schools**.

Just 3% reply "not at all involved."

23. 66% of all current HPS parents believe **Hudsonville's schools are PHYSICALLY "extremely or very safe" for their children**.

Only 2% reply "not at all safe."

24. 55% of all current HPS parents believe **Hudsonville's schools are EMOTIONALLY "extremely or very safe" for their children**. Only 4% reply "not at all safe." 25. Approximately three-fourths of current parents at HPS schools believe the **entrances at their children's schools are safe** ... 78% ("definitely or probably yes") of Early Childhood Center parents, 79% of elementary school parents, 81% of middle school parents, and 71% of the high school parents.

Few reply "no," at most 15% of Early Childhood Center parents.

26. Strong agreement that **HPS parking lots are safe where parents are dropping off and picking up their children** ranges from 69% ("extremely" or "very safe") for HPS middle school parents to 39% of the high school parents. Few reply "not at all safe," at most 10% among the high school parents.

Few reply "not at all safe," at most 10% among the high school parents.

27. The percentage of current HPS parents who are "completely or very satisfied" with **how student discipline is consistently enforced in their SCHOOLS** is very strong in the Early Childhood Center (87%) and then progressively declines to 65% in their elementary schools, 53% in their middle schools, and 47% at the high school. Few are "not at all satisfied," at most 13% among the high school parents.

28. The percentage of current HPS parents who are "completely or very satisfied" with **how student discipline is consistently enforced on their BUSES** includes only 46% of elementary school parents, 43% of middle school parents, and 43% of high school parents. Approximately 10% are "not at all satisfied."

29. The percentage of current HPS parents who are "completely or very satisfied" with **how HPS addresses bullying in their SCHOOLS** is highest at 80% in the Early Childhood Center, and then progressively declines to 60% in their elementary schools, 44% in their middle schools, and 31% at the high school.

Few are "not at all satisfied," at most 14% among the high school parents.

30. The percentage of current HPS parents who are "completely" or "very satisfied" with **how HPS addresses bullying on their school BUSES** includes only 34% of the elementary schools parents, 29% of the middle schools parents, and 29% of the high school level parents. "Not at all satisfied" are at most 15% among the high school level parents.

31. 37% of all current HPS parents are "completely or very satisfied" with **how HPS** addresses cyber bullying DURING the school day.

13% are "not at all satisfied," at most 14% of the elementary school parents.

32. 29% of all current HPS parents are "completely or satisfied" with **how HPS addresses** cyber bullying OUTSIDE the school day.

18% are "not at all satisfied," at most 20% of the high school parents.

33. 67% of all current HPS parents say they are **"extremely or very familiar" with the district's PBIS initiative**, ranging from 75% of the elementary school parents to 56% of the high school parents.

Only 6% are "not at all familiar."

34. 67% of all current HPS parents believe that the **PBIS programming has helped their students with their behavior**, ranging from 86% of Early Childhood Center parents to 55% of the high school parents.

10% do not feel it has been helpful, while 22% are "not sure."

35. Most current Early Childhood Center (96%) and HPS elementary school parents (91%) agree that there is **at least one teacher or administrator or other staff member who knows their child well enough to recognize if something was different or troubling their child**.

However, the combined "definitely or probably yes" replies then decline to 71% of HPS middle school parents and 62% of the high school parents.

Few reply "no," at most 18% of the high school parents.

36. More frequently mentioned **unaided comments about School and District Environment** include:

- The district can do more to address misbehavior, discipline and bullying, both at school and on the buses.
- Some parents feel that programs that encourage positive behavior are not effective without also having negative consequences for inappropriate behavior.
- Specifically, some parents do not feel the district and their larger Hudsonville community are supportive or welcoming to ALL students, leading to students harassing others for race and sexual orientation without consequences for their behavior.
- Some parents feel that the district is not supportive of families with what they describe as "traditional" values.
- Parents still note that communications from individual teachers and schools declines as their child ages and progresses through the grades.
- More vigilance to assure security, especially with checking everyone at the office entrances at the school buildings.

37. 75% of current HPS parents are "completely or very satisfied" with the **importance** placed on academic achievement by HPS STUDENTS.

71% are "completely or very satisfied" (82%) with the **importance placed on academic achievement by PARENTS of current HPS students**.

79% are "completely or very satisfied" with the **importance placed on academic achievement by HPS STAFF**.

55% are "completely or very satisfied" with the **importance placed on academic achievement by the HPS BOARD of Education**.

55% are "completely or very satisfied" with the **importance placed on academic achievement by the Hudsonville COMMUNITY**.

38. The percentage of current HPS parents who are "completely or very satisfied" with **HPS'** educational programs and resources to deliver today's teaching and learning ranges from 90% at the Early Childhood Center to 64% at their middle schools. Very few are "not at all satisfied," at most 3% at the Early Childhood Center and middle schools.

39. The percentage of current HPS parents who are "completely or very satisfied" with **how HPS helps parents support their children's learning** ranges from 88% at the Early Childhood Center to 57% at the high school.

Very few are "not at all satisfied," at most 7% among high school parents.

40. 67% of current HPS parents want to learn more about how math is taught today in HPS so that they can better support their children's math instruction and

homework, including 31% who reply "definitely yes." Many more parents at the Early Childhood Center (82%) and at their elementary schools (77%) reply "yes" than do the parents at their middle schools (60%) and high school (49%). 21% do not care to learn more about how math is taught to better support their children's math instruction, while 12% are "not sure."

41. The percentage of current HPS parents who are "completely or very satisfied" with the **attention and support HPS gives to students who are struggling with READING** is considerably higher at the Early Childhood Center (78%) and at their elementary schools (69%) than it is at their middle schools (51%) and high school (44%). Few are "not at all satisfied," at most 12% among high school parents.

42. The percentage of current HPS parents who are "completely or very satisfied" with the **attention and support HPS gives to students who are struggling with MATH** is noticeably higher at the Early Childhood Center (77%) and at their elementary schools (65%) than it is at their middle schools (50%) and high school (42%). Few are "not at all satisfied," at most 12% among high school parents.



43. The percentage of current HPS parents who are "completely or very satisfied" with the **attention and support HPS gives to students who are STRUGGLING ACADEMICALLY** is substantially higher at the Early Childhood Center (68%) and at their elementary schools (68%) than it is at their middle schools (52%) and high school (43%). Few are "not at all satisfied," at most 8% among middle school parents.

44. The percentage of current HPS parents who are "completely or very satisfied" with the **academic assistance and tutoring HPS teachers and staff provide AFTER SCHOOL to students who are struggling academically** is considerably higher at their elementary schools (68%) than it is at their middle schools (59%) and high school (51%). Few are "not at all satisfied," at most 12% among high school parents.

45. Explicitly labeled AP and Honors classes probably explain why the percentage of current HPS parents who are "completely or very satisfied" with the **attention and support HPS gives to students who are ACADEMICALLY ADVANCED** is noticeably higher at the high school level (48%) than in their elementary schools (36%) or in their middle schools (30%). 23% of the middle school parents are "not at all satisfied," which is significantly increased from the 2020 SOAR Parents survey.

46. 64% of all current HPS parents are "completely or very satisfied" with **HPS students' performance on standardized tests**. Just 3% are "not at all satisfied."

47. 83% of current HPS high school parents believe **Hudsonville's graduates are prepared to continue their formal education**, 69% for **work and careers**, and 61% for **everyday life**.

48. 36% of current HPS parents believe that **HPS supports students who take an alternative pathway to graduation**, including 10% who reply "definitely yes." 13% say HPS has not been supportive, while 50% are "not sure."

49. 71% of current HPS parents feel that HPS is "just about right" with its **balance of instructional time given to STEAM versus literature and Social Studies classes**. 24% say not enough instructional time is given to STEAM classes, while only 5% believe too much instructional time is given to STEAM classes.

50. The percentage of current HPS parents who are "completely or very satisfied" with **how technology is used to enhance everyday teaching and learning in their children's classrooms** ranges from 72% at the Early Childhood Center to 62% at the high school. Very few are "not at all satisfied," at most 5% among both Early Childhood Center and high school parents.

51. 55% of current HPS elementary school parents say it is "extremely or very important" that HPS **expand its world/foreign language instruction in its elementary schools**, while 11% reply "not at all important."

56% of current HPS middle school parents say it is "extremely or very important" that HPS **expand its world/foreign language instruction in its middle schools**, while 9% reply "not at all important."

47% of current HPS high school parents say it is "extremely or very important" that HPS **expand its world/foreign language instruction in the high school**, while 14% reply "not at all important."

52. 58% of HPS middle school parents are "completely or very satisfied" with the **breadth of electives available at their middle schools**, while just 4% are "not at all satisfied."

66% of HPS high school parents are "completely or very satisfied" with the **breadth of** electives available at their high school, while only 4% are "not at all satisfied."

53. As expected, **familiarity with the Careerline Tech Center** is strongest among the HPS high school parents, with 28% saying they "know a lot" about it and another 52% who "know a little" about it.

20% of all current HPS parents say they "know a lot" about the Careerline Tech Center and another 40% say they "know a little about it."

28% of all current HPS parents are "not familiar at all," but including only 12% of the high school parents.

54. 66% of current HPS parents, including 71% of the high school parents, are "completely or very satisfied" with the **classes available at the Careerline Tech Center**.

11% of current HPS parents and just 5% of the high school parents are "not at all satisfied."

55. 92% of the HPS high school parents believe **Personal Finance should be a required class to graduate** from Hudsonville High School, including a strong 68% who reply "definitely yes."

83% of the high school parents believe **Personal Living/Life Skills should be a required class to graduate**, including a considerable 52% who reply "definitely yes."

Only 37% of the high school parents agree that **Technology/Coding should be a required class to graduate**, including only 8% who reply "definitely yes." An identical 37% reply "no," while 26% are "not sure."

56. 55% of the HPS high school parents believe there should be **a required minimum number of hours of community service or volunteering to graduate from HPS**. 39% reply "no," while 17% are "not sure."

57. 63% of HPS elementary school level parents are "completely or very satisfied" with the HPS **before- and after-school child care program**.

Only 8% of the elementary school parents are "not at all satisfied."

58. 53% of all current HPS parents **prefer trimesters to semesters**, including 24% who "definitely prefer trimesters."

Only 19% prefer semesters, including just 8% who "definitely prefer semesters." 27% are "not sure."

59. The percent of "completely or very satisfied" responses for the support from HPS for families with children with social, emotional or behavioral issues is highest among Early Childhood Center parents (72%) and elementary school parents (57%), but then declines to 41% of the middle school parents and 35% of the high school parents. Few are "not at all satisfied," at most 12% among the high school parents.

60. The percent of "completely or very satisfied" responses for the **information from HPS about community resources to assist families with children with social, emotional or behavioral issues** ranges from 64% of Early Childhood Center parents to only 31% of the high school parents.

"Not at all satisfied" responses are highest among the middle school parents (19%).

61. "Completely or very satisfied" responses for **how HPS teaches its students to learn to know who they are as a person** include 66% of Early Childhood Center parents, 48% of the elementary school parents, 35% of the middle school parents, and 39% of the high school parents.

"Not at all satisfied" responses are highest among the high school parents (18%).

"Definitely or probably yes" responses to **if it is important for HPS to teach its students to learn to know who they are as a person** include 64% of Early Childhood Center parents, 53% of the elementary school parents, 50% of the middle school parents, and 47% of the high school parents.

"Definitely or probably no" responses are highest among the high school parents (39%).

63. "Completely or very satisfied" responses for **how HPS teaches its students to learn to have empathy for others** include 82% of Early Childhood Center parents, 60% of the elementary school parents, 42% of middle school parents, and 33% of high school parents. "Not at all satisfied" responses are highest among the high school parents (13%).

"Definitely or probably yes" responses to **if it is important for HPS to teach its students to learn to have empathy for others** include 98% of Early Childhood Center parents, 89% of the elementary school parents, 85% of middle school parents, and 79% of high school parents. "Definitely or probably no" responses are highest among the high school parents (12%).

64. "Completely or very satisfied" responses for **how HPS teaches its students to learn to be responsible for their own actions** include 84% of Early Childhood Center parents, 72% of the elementary school parents, 54% of middle school parents, and 50% of high school parents. Few are "not at all satisfied," at most 7% among the high school parents.

"Definitely or probably yes" responses to **if it is important for HPS to teach its students to learn to be responsible for their own actions** include 98% of Early Childhood Center parents, 96% of the elementary school parents, 94% of the middle school parents, and 90% of the high school parents.

"Definitely or probably no" responses are highest among the high school parents (6%).

65. More frequently mentioned **unaided comments about Curriculum, Instruction, Learning and Achievement** include:

- More attention, resources or support for individual students, both those who are struggling academically or not being sufficiently challenged academically.
- Confusion and sometimes dissatisfaction with how reading and math are taught.
- Some parents feel that HPS should only teach "academics" or "the basics," while other parents feel that social emotional learning is essential to their children's education and experiences.
- More support for children with extreme behavior issues so that their entire class is not distracted from learning.
- ✤ More life skills and career oriented instructional content.

66. **Overall satisfaction with HPS special education services** ranges f from 74% of Early Childhood Center special education parents who are "completely or very satisfied" to 59% of middle school special education parents.

Few are "not at all satisfied," at most 11% among Early Childhood Center special education parents.

67. 73% of current HPS parents with children receiving special education services are "completely or very satisfied" with the **INITIAL EVALUATION process,** including 41% who are "completely satisfied."

10% are "not at all satisfied."

68. 70% of current HPS parents with children receiving special education services are "completely or very satisfied" with **ANY RE-EVALUATION process,** including 38% who are "completely satisfied."

Only 6% are "not at all satisfied."

69. More frequently mentioned **unaided comments about Special Education services** include:

- Several parents take the time to praise the HPS special education services and specific staff members
- More communication needed between Special Ed staff and parents
- Delays in establishing an IEP
- Some parents feel that special education services are not as available in middle school as they were at the elementary school level.

70. 83% of HPS high school parents are "completely or very satisfied" with the **number of arts opportunities for its HIGH school students**. Just 1% are "not at all satisfied."

83% of HPS middle school parents are "completely or very satisfied" with the **number of arts opportunities for its MIDDLE school students**. Fewer than 1% are "not at all satisfied."

71. Reflecting continued satisfaction with the Fine Arts Auditorium, 83% of all current HPS parents are "completely or very satisfied" with the **quality of HPS performing and fine arts facilities**, including 41% who are "completely satisfied." Very few, just 2%, are "not at all satisfied."

72. The Fine Arts Auditorium perhaps also continues to favorably influence the quality of arts programming, as 87% of all current HPS parents are now "completely or very satisfied" with the **quality of HPS arts programming**, including 37% who are "completely satisfied." Very few, just 2%, are "not at all satisfied."

73. 86% of HPS high school parents are "completely or very satisfied" with the **number of HIGH school arts performances**. Just 3% are "not at all satisfied."

81% of HPS middle schools parents are "completely or very satisfied" with the **number of MIDDLE school arts performances**. Just 3% are "not at all satisfied."

74. More frequently mentioned **unaided comments about Performing and Fine Arts** include:

- A number of parents take the time to applaud the Performing and Fine Arts programs and individual staff members.
- Some parents do not want 6th-graders to be required to take a music program.
- More art, music and theater choices and opportunities in their schools, especially at the elementary school level.
- ♦ More funding and support for the performing and visual arts.

75. 32% of Baldwin and Riley Middle School parents say they are "extremely or very **informed" about the extra-curricular activities and clubs for their MIDDLE school children**.

12% say they are "not at all informed."

24% of HPS high school parents say they are "extremely or very **informed" about the extracurricular activities and clubs for their HIGH school children**. 15% say they are "not at all informed."

76. 44% of Baldwin and Riley Middle School parents are "completely or very **satisfied" with the extra-curricular activities and clubs for its MIDDLE school students**.

Only 5% are "not at all satisfied."

45% of HPS high school parents are "completely or very **satisfied" with the extracurricular activities and clubs for its HIGH school students**. 8% are "not at all satisfied."

77. More frequently mentioned **unaided comments about Extra-Curricular Activities and Clubs** include:

- Parents want to receive more information about the extra-curricular activities and clubs available for their children.
- Elementary school parents seek more extra-curricular activities and clubs for their children.
- Special ed parents seek more extra-curricular activities and clubs for their children.

78. 38%t of the HPS high school parents are "completely or very satisfied" with the **opportunity to participate on HIGH school teams**.

HPS **athletic program attributes** with at least 70% of these high school parents who are "completely or very satisfied" are:

- Girls have as many athletic opportunities as do boys (81%)
- ✤ Athletes held to academic standards (74%)
- Number of different sports teams available to Hudsonville High School students (74%).
- ✤ Coaches encourage good sportsmanship (70%)

There are very few "not at all satisfied" ratings of the athletic program from these high school parents, at most 14% for the opportunity to participate on high school teams.

79. 56% of the HPS middle school parents are "completely or very satisfied" with the **opportunity to participate on MIDDLE school teams**.

Moreover, these middle school parents continue to be even more pessimistic about the opportunity to participate on the **HIGH school** teams, with just 38% "completely or very satisfied" and 17% "not at all satisfied."

HPS **athletic program attributes** with at least 70% of these middle school parents who are "completely or very satisfied" are:

- Girls have as many athletic opportunities as do boys (78%)
- ✤ Coaches encourage good sportsmanship (77%)
- ✤ Athletes held to academic standards (77%)
- ✤ Coach communications with parents (71%)
- ✤ Athletes held to citizenship standards (71%)

80. 59% of the HPS elementary school parents say it is "extremely or very important" to **add an intramural sports program for their elementary school children**. 9% reply "not at all important."

74% of Baldwin and Riley Middle School parents say it is "extremely or very important" to **add an intramural sports program for their middle school children**. Just 5% reply "not at all important."

67% of the High School parents say it is "extremely or very important" to add an intramural sports program for their high school children. 8% reply "not at all important."

81. More frequently mentioned **unaided comments about Athletics** include:

- Parents definitely would welcome intramural sports to enable more kids to be able to participate.
- Parents continue to write about how Hudsonville's size and no second high school limit athletic team opportunities to only a few kids and "many talented kids don't get a chance to play."
- Coaches rely too much on their players to inform their parents, and ask for more direct and more frequent communications.
- Of course, some parents do not like how certain coaches coach their sport and team, especially with respect to favoring certain players over others.
- Some parents feel boys sports and teams are still supported more than girls teams.

82. **Familiarity with the HPS Community Education program** is noticeably improved from the 2020 SOAR Parents survey, now with 47% of all current HPS parents saying they "know a lot" about the Community Education program.

Another 41% say they "know a little" about it and 4% "only have heard its name." 9% are "not familiar at all."

83. 57% of all HPS current parents "completely or very satisfied with the HPS Community Education ADULT programs and classes.

Just 4% are "not at all satisfied."

84. 74% of all HPS current parents "completely or very satisfied with the HPS Community Education YOUTH programs and classes.

Only 1% are "not at all satisfied."

85. More frequently mentioned **unaided comments about Community Education** include:

- Demand for a greater variety of Community Ed classes for all ages, with some comparing Hudsonville unfavorably to Zeeland 's selections.
- More and earlier distributed information about Community Ed programs available for both youths and adults.

86. 71% of current HPS parents say HPS is "extremely" or "very responsible" with **how it manages and spends its annual OPERATING budget**. Only 3% reply "not at all responsible."

87. 73% of current HPS parents say HPS has been "extremely" or "very responsible" with **how it manages and uses the funds approved by voters in past BOND issues**. Just 4% reply "not at all responsible."

88. 73% of current HPS parents say HPS has been "extremely or very responsible" with **how it manages and uses the funds approved by its Building and Site Fund dollars**. Only 3% reply "not at all responsible."

89. 68% of current HPS parents say Hudsonville Public Schools has been "extremely" or "very responsible" with **how it manages and uses the funds from the OAISD Enhancement Millage**.

Just 4% reply "not at all responsible."

90. 55% of HPS current parents are "completely or very satisfied" with **how HPS has taken input from the last SOAR survey to make improvements**. 8% are "not at all satisfied."

91. 56% of current HPS parents prefer a later (30 to 60 minutes) start and end for middle and high school students, with elementary school students then starting and ending their school day 30 to 60 minutes earlier. This includes 24% who reply "definitely ves."

26% reply "no," while 19% are "not sure."

The highest percentage of "yes" responses is by Early Childhood Center parents (65%), while the highest percentage of "no" responses is by the high school parents (28%).

92. More frequently mentioned **unaided comments about Finance and Management** include:

- Some parents oppose a later start/end time for middle and high school students because work and athletic team practices after school would be pushed too late in the day.
- Other parents agree with the science behind a later start/end time for teen-agers but prefer that every school level starts and ends at the same time.
- ✤ As expected, some parents applaud the district for being financially responsible, while other parents point to what the perceive as misguided spending priorities and waste.
- Some parents prefer money to be spent on hiring more teachers and social workers rather than on buildings, not understanding how Michigan schools are financed.
- Some parents feel that the district is wasting money spent on social emotional learning and DEIB programs.

93. More frequently mentioned **unaided additional verbatim comments** include:

- Specific teachers and staff members are praised by name.
- Some parents feel the district has grown too large and should be split.
- Again, some parents feel HPS and public schools are following a too progressive political agenda, while other parents feel that the district's Board is increasingly intentionally exclusionary and discriminatory.
- Several parents note their appreciation for the SOAR research and strategic planning ... "Thank you for reaching out to parents/community and asking."

SAMPLE PROFILE

Preschool children

Eighteen percent of parents with children currently attending HPS responding to this survey have preschool-age children.

Among these current HPS parents with preschool age children, 86% have their preschoolers attend a preschool program, including 3% attend a home-based preschool program. Helpfulness of resources to communicate to parents

School Messenger (80% "extremely or very helpful"), school newsletters (72%), PowerSchool (58%), and the district newsletter Appleseed (52%) are considered as the most helpful communications resources by current HPS parents to keep them and the community informed about the district.

Additional comments on School and District Environment

Q. Do you have additional comments about School and District Environment?

More frequently mentioned comments include:

- The district can do more to address misbehavior, discipline and bullying, both at school and on the buses.
- Some parents feel that programs that encourage positive behavior are not effective without also having negative consequences for inappropriate behavior.
- Specifically, some parents do not feel the district and their larger Hudsonville community are supportive or welcoming to ALL students, leading to students harassing others for race and sexual orientation without consequences for their behavior.
- Some parents feel that the district is not supportive of families with what they describe as "traditional" values.
- Parents still note that communications from individual teachers and schools declines as their child ages and progresses through the grades.
- More vigilance to assure security, especially with checking everyone at the office entrances at the school buildings.

Satisfaction with HPS athletic programs

HPS athletic program attributes with **at least 70% of the current HPS high school parents who are "completely or very satisfied"** are:

- Girls have as many athletic opportunities as do boys (81%)
- ✤ Athletes held to academic standards (74%)
- Number of different sports teams available to Hudsonville High School students (74%).
- ✤ Coaches encourage good sportsmanship (70%)

However, a strong satisfaction with the **opportunity** to participate on high school teams is significantly less at just 38% "completely or very satisfied."

There are very few "not at all satisfied" ratings of the athletic program from current HPS high school parents, at most 14% for the opportunity to participate on high school teams.

HPS athletic program attributes with **at least 70% of the current HPS middle schools parents who are "completely or very satisfied"** are:

Again, a strong satisfaction with the **opportunity** to participate on middle school teams is considerably less at just 56% "completely or very satisfied."

Moreover, the HPS middle schools parents continue to be even more pessimistic about the opportunity to participate on the **high school** teams, with just 38% "completely or very satisfied" and 17% "not at all satisfied."

Later start/end for middle and high school students, with elementary school students starting/ending earlier

Fifty-six percent of all current HPS parents prefer a later (30 to 60 minutes) start and end for middle and high school students, with elementary school students then starting and ending their school day 30 to 60 minutes earlier. This includes approximately one-fourth who reply "definitely yes" (24%).

Twenty-six percent reply "no," while 19% are "not sure."

The highest percentage of "yes" responses is by Early Childhood Center parents (65%), while the highest percentage of "no" responses is by the high school parents (28%).

Q. Some school districts in other states have modified the starting time for elementary and secondary students. This is based on the proven science that teenagers' body clocks (circadian body rhythm) naturally fall asleep later (11:00pm or later), while younger children naturally fall asleep and awaken earlier. Moreover, teenagers' changing hormones lead them to need more sleep. Because we need two separate bus routes, they cannot all start at the same time. So how would you feel if middle and high school students started and ended their school day 30 to 60 minutes later, while elementary school students started and ended their school day 30 to 60 minutes earlier?

Additional comments on Finances and Management

Q. Do you have any additional comments about Finances and Management?

More frequently mentioned unaided comments include:

- Some parents oppose a later start/end time for middle and high school students because work and athletic team practices after school would be pushed too late in the day.
- Other parents agree with the science behind a later start/end time for teen-agers but prefer that every school level starts and ends at the same time.
- ✤ As expected, some parents applaud the district for being financially responsible, while other parents point to what the perceive as misguided spending priorities and waste.
- Some parents prefer money to be spent on hiring more teachers and social workers rather than on buildings, not understanding how Michigan schools are financed.
- Some parents feel that the district is wasting money spent on social emotional learning and DEIB programs.

- ✤ "More online or blended learning opportunities" (37%)
- ✤ "Stricter classroom discipline" (45%)
- "Fewer students in a classroom even if it means eliminating other things to afford the additional teaching staff" (47%)

Ten percent or more of current HPS parents consider the following as "not at all important") improvements:

- Concerns about enrollment growth, especially at the high school, with too many kids at each grade level and in each classroom.
- Some parents feel not enough attention or resources are given to their children who are academically advanced and not challenged enough in school.
- Other parents feel not enough attention or resources are given to their children who are struggling in school academically or behaviorally.
- * Misbehaving students are not held accountable.
- As expected, some parents feel HPS and public schools have a too progressive political agenda, while other parents feel that the district is increasingly following an agenda that is exclusionary and discriminatory.

Recommend to families to enroll their children in HPS

Slightly more than three-fourths of current HPS parents (77%) would recommend to families to enroll their children in Hudsonville Public Schools, including 39% who say "definitely yes."

The percentage of "definitely yes" replies includes 56% of current HPS Early Childhood Center parents, 41% of the elementary school parents, 36% of the middle school parents, and 33% of the high school parents.

Ten percent of current HPS parents would not recommend to families to enroll their children in Hudsonville Public Schools, while 13% reply "nor sure."
